

Chair Jesus Arias addressed the membership in a September 18, 2018 letter inviting members to provide input in a short survey.

### Member Survey Results



On September 18, 2018, section members were invited to take a survey to help the Executive Committee better serve the membership. The results are in:

- While 80% of participants showed a preference for international arbitration, a fair number of participants expressed interest in international family law issues.
- A third of participants are located in downtown Los Angeles.
- 100% of participants indicated an interest in MCLE programs.
- While 73% of participants indicated an interest in weekday evening events, 53% of participants said they would be available for weekday lunch events as well.
