

Probate Reopening 2nd Townhall meeting

Riverside Superior Court

Filing

- Certified copies
 - By mail or drop-box, see [Probate Reopening FAQs](#).
 - Soon – by eSubmit – watch for an announcement
- Getting Order/Letters after a telephonic hearing
 - File required documents (e.g. Proposed Order, Proposed Letters, Bond).
 - Address all outstanding probate note deficiencies and order questions.
 - Complete all of the above at least 4 court days prior to the hearing.
- Original Wills and Bonds
 - Deliver to the court either by U.S. Mail or in the drop box in front of the probate courthouse.
- Drop box hours: 7:30a.m. - 4:00p.m.
- Filings received during court closure
 - Effective filing date: 5/11/20.
 - If copies to conform were submitted with a self-addressed stamped envelope but were not received, please email probatewebassistance@riverside.courts.ca.gov

Hearings

- Report of sale
 - All in-person hearings
 - Before 7/1:
 - If an overbidder appears, the hearing will be continued briefly to allow an in-person hearing.
 - After 7/1:
 - Location:
 - Western and Mid-County regions: Department 11
 - Desert region: TBD
 - Change of time:
 - 1:30 pm
 - Posting:
 - At normal courthouse locations
 - For hearings after 7/1, Notice of Temporary Location Change will also be posted, and attached to posted Report of Sale petition.
- Elder Abuse
 - In-Person hearings resumed on 5/18
 - In-Person Hearing Time and Location Change
 - Western and Mid-County Regions:

- For petitions filed before 6/2, hearings are set in Department 55.
- Starting with petitions filed 6/2, all hearings will be in Department 11.
- Time: 1:30 p.m.
- Desert Region:
 - Hearings on or before 6/12:
 - Department 3P at 10:00 a.m.
 - Hearings on 6/15 and after:
 - Department 1B at 8:30 a.m.
- All other matters (except LPS Conservatorship)
 - Morning hearings: Starting 6/15 and until further notice, hearings will be conducted solely by WebEx (not CourtCall).
 - Afternoon hearings: Trial dates through August will be continued
 - Trials in civil departments: May be continued on a case by case basis by the civil judge to which your case is assigned.
